## SARS Elektroniese betalings

Verlede jaar het SARS die betalingsopsies uitgebrei en verbeter om potensiele foute en foutiewe allokasie van betalings te verminder deur die bekendstelling van nuwe betaalkanale. Die suksesvolle oorskakeling van die vorige stelsel van genomineerde FNB rekeninge na die nuwe bevoordeelde ID sisteem via FNB, ABSA, Standard Bank en Nedbank het SARS daartoe in staat gestel om die genomineerde FNB rekeninge te sluit.

Betalings wat in die ou FNB genomineerde rekeninge inbetaal word na 31 Julie 2007 sal nie deur die banke geprosesseer word nie.

Soos u reeds kennis dra het die nuwe Nasionale Kredietwet in werking getree op die 1ste Junie 2007.

Die meeste van ons kliente verskaf toevallige krediet aan hulle kliente, dus hoef hulle nie te registreer as 'n kredietverskaffer nie.

Ons, as firma, verskaf ook toevallige krediet aan u as klient. Hierdie krediet moet binne 30 dae terugbetaal word aangesien dit toevallig is. Ons vra u vriendelik dat u asseblief daarop sal let in die toekoms.

## Income tax returns for 2007

As we all have seen in the media, the income tax returns were changed. It have been simplified and are easier to submit, as no supporting documents have to be submitted with the income tax return.

Extension have been granted until the end of October 2007 for everyone. But, if you have registered for e-filing, the extension will be automatically granted up to the end of January 2008.

We have registered all our clients for e-filing and are planning to submit all the income tax returns via e-filing for 2007.

SARS will visit us in August 2007 to educate us in this process.

The days whereby one could request SARS for an extension are long gone, they are now very strict regarding the promptness of tax returns.

### **Krediet tjeks vanaf SARS**

Vanaf 1 Augustus 2007 reik SARS nie meer tjeks uit vir krediete op inkomste belasting en BTW nie. SARS probeer om korrupsie so hok te slaan en alle krediet sal direk in u bankrekening in betaal word.

Die onus is dus op u as kliënt om ons in kennis te stel sodra u bankrekening besonderhede verander, sodat ons SARS so spoedig as moontlik in kennis daarvan kan stel.

### **Hospitality Sector Basic Conditions of Employment Act**

According to the Government Gazette of the 15th May 2007, the minimum wages for the hospitality sector will become effective from the 1st July 2007.

The Hospitality Sector is defined as:

- means any commercial business or part of a commercial business in which employers and employees are associated for the purpose of carrying on or conducting one or more of the following activities for reward:

a) providing accommodation in a hotel, motel, inn, resort, game lodge, hostel, guest house or bed and breakfast establishment, including short stay accommodation, self-catering timeshares, camps, caravan parks;

b) restaurants, pubs, taverns, cafés, tearooms, coffee shops, fast food outlets, snack bars, industrial and commercial caterers, function caterers, contract caterers that prepare, serve and provide prepared food and liquid refreshments, other than drinks in sealed bottles or cans whether indoors or outdoors or in open air, for consumption on or off the premises, and

c) includes all activities or operations to or arising from any of the activities mentioned in paragraph (a) and (b).

Minimum rate for the period 1 <sup>st</sup> July 2007 to 30 <sup>th</sup> June 2008 (for employers with 10 or less employees)

### **Sperdatums**

U moet asseblief let op die sperdatums vir tjeks of opgawes wat ons moet bereik. Gewoonlik word die sperdatum 'n week voor die werklike indieningsdatum vasgestel.

Ons moet op die sperdatum die betrokke inligting ontvang, sodat ons dit betyds by die betrokke instansie kan indien of in betaal.

### **Input VAT on second-hand goods**

Vendors are allowed to claim an input VAT deduction where second-hand goods are acquired from a non-registered vendor.

The following records must be retained and a VAT264 must be completed and signed by the seller:

- ◆ name and address of the person who sold the goods,
- ◆ verification of his name, his ID number, or if the purchase is R1000 or more, a photocopy of his ID document,
- ◆ registration number of company/close corporation if the amount is more than R1000,
- ◆ date of purchase,
- ◆ description of the goods,
- ◆ quantity, mass or volume of the goods,
- ◆ purchase price,
- ◆ proof of payment of the purchase price.

### **BTW – 6 MAANDELIKS**

Dit is weer BTW tyd vir die boere. Die BTW-opgawes moet voor die 21ste September 2007 ingedien wees en strek vir die periode vanaf 1 Maart 2007 tot 31 Augustus 2007. Die 24ste September is Erfenisdag.

Ons versoek die kliënte om asseblief so gou as moontlik na 31 Augustus 2007 die inligting in te bring om ons in staat te stel om die opgawes betyds te kan voltooi.

### **Dieselrabat**

Vanaf 1 April 2007 is die dieselrabat verhoog vanaf 76,5c/l na 83,5c/l.

### **Trusts**
